- Any processing or transferring of the Credit under this Application shall be subject to the version of the Uniform Customs and Practice for Documentary Credits, International Chamber of Commerce Publication ("UCP") stated in that Credit, or in the absence of such version being so stated, the latest revised version of the UCP which is in force as of the date of this Application.
- This Application between the Bank and us shall be governed by, and construed in accordance with, the laws of the Kingdom of Cambodia.
